Re: Notice of Publication of an Additional Further Proposed Main Modification (Submission Document: CS54) to the Eastbourne Plan: Core Strategy (The Town and Country Planning (Local Planning) (England) Regulations 2012)

The Examination in Public on the Eastbourne Plan: Core Strategy took place in May 2012. Following the list of proposed main modifications and further proposed main modification, upon which stakeholders and the local community were invited to make representations, the Council is now publishing additional further proposed main modifications to the Core Strategy. These modifications are set out in Submission Document: CS54 Additional Further Proposed Main Modifications (31 August, 2012) and relate to Policy D6: Gypsies, Travellers and Travelling Showpeople. The consultation will run from Friday 31 August to Friday 12 October 2012.

Stakeholders and the local community are invited to make representations on Submission Document: CS54. It should be stressed that representations should only comment on this document and not other elements of the Core Strategy. All representations received will be sent to, and duly considered by the Planning Inspector.

Submission Document: CS54 should be read in conjunction with the Eastbourne Plan: Core Strategy Proposed Submission Version and Addendum to the Sustainability Appraisal.
