Re: Notice of Publication of the Schedule of Proposed Main Modifications to the Eastbourne Plan: Core Strategy (The Town and Country Planning (Local Planning) (England) Regulations 2012)

The Examination in Public on the Eastbourne Plan: Core Strategy has now concluded. During the hearing sessions, the Planning Inspector sought additional information or clarification from the Council on a number of matters. The Council was invited to put forward suggested amendments to address or clarify these issues and these have been duly set out.

The Council is publishing a list of Proposed Main Modifications (June 2012) (Submission Document CS2 (G)) for a six-week consultation period on matters of soundness, from Friday 22<sup>nd</sup> June to Friday 3<sup>rd</sup> August, 2012. Stakeholders and the local community are invited to comment on these proposed main modifications. It should, however, be stressed that representations should only comment on the Proposed Main Modifications and not other elements of the Plan, which have already been considered during the recent Examination in Public. These comments will then be considered by the Planning Inspector.
