BYELAWS

Made under Section 68 of the Town Police Clauses Act 1847 and Section 171 of the Public Health Act 1875 by the Council of the Borough of Eastbourne in respect of hackney carriages in the Borough of Eastbourne

The Byelaw Number 12 made by the Council of the Borough of Eastbourne of the Ninth day of May One thousand nine hundred and seventy eight and confirmed by one of Her Majesty's Principal Secretaries of State on the Twenty second day of June One thousand nine hundred and seventy eight is hereby repealed and replaced by the following Byelaw which shall be read and construed as one with the series made by the Council of the County Borough of Eastbourne on the Fourteenth day of October One thousand nine hundred and seventy and confirmed by one of the said Principal Secretaries of State on the Fifteenth day of December One thousand nine hundred and seventy

12. Each of the several places specified in the following list shall be a stand for such numbers of hackney carriages as is specified in the list:-

PROPOSED TAXI STANDS

<u>POSITION</u>	<u>NUMBER OF HACKNEY CARRIAGES AUTHORISED</u>
<u>ASHFORD ROAD (SOUTH-EAST SIDE)</u>  Commencing from a point 78 feet (23.77m) south-west of its junction with the emergency access road to the Arndale Centre for a distance of 36 feet (10.97m) in a north-easterly direction	2
<u>BOLTON ROAD (WEST SIDE)</u>  Commencing from a point 7 feet (2.14m) south of its junction with Terminus Road for a distance of 112 feet (34.13m) in a southerly direction	7

BOLTON ROAD (EAST SIDE)

Commencing from a point 245 feet (74.63m) south of its junction with Terminus Road for a distance of 48 feet (14.63m) in a southerly direction

CORNFIELD ROAD (EAST SIDE)

Commencing from a point 2 feet (0.61m) north from a position opposite the northern kerbline of Hyde Gardens (north) for a distance of 44 feet (13.41m) in a southerly direction

HYDE GARDENS (NORTH) (NORTHSIDE)

Commencing from a point 14 feet (4.26m) west of its junction with Cornfield Road for a distance of 80 feet (24.38m) in a westerly direction

Note: The two spaces on this stand nearest the junction with Cornfield Road are not to be used between 7.00 a.m. and 9.00 a.m.

LANGNEY ROAD (SOUTH EAST SIDE) NO. 1

Commencing from a point 38 feet (11.58m) north-east of its junction with Terminus Road for a distance of 64 feet (19.5m) in a north-easterly direction

LANGNEY ROAD (SOUTH EAST SIDE) NO. 2

Commencing from a point 122 feet (37.17m) north-east of its junction with Terminus Road for a distance of 32 feet (9.75m) in a north-easterly direction

OLD ORCHARD ROAD (NORTH WEST SIDE)  
NO. 1

Commencing from a point 16 feet (4.87m) south-west of its junction with Southfields Road for a distance of 112 feet (34.13m) in a south-westerly direction 7

OLD ORCHARD ROAD (NORTH WEST SIDE)  
NO. 2

Commencing from a point 83 feet (25.3m) north-east of its junction with Arlington Road for a distance of 64 feet (19.5m) in a north-easterly direction 4

CAVENDISH PLACE (SOUTH WEST SIDE)

Commencing from a point 110 feet (33.528m) south-east of its junction with Pevensey Road and extending in a south-easterly direction for a distance of 65 feet (19.812m) 3

GROVE ROAD (EAST SIDE)

Commencing 45 feet (13.6m) south of its junction with Ivy Terrace for a distance of 20 feet (6.069m) in a southerly direction 1

TERMINUS ROAD (NORTH SIDE)

Against traffic island outside south-west entrance to the Eastbourne Railway Station 2

PEVENSEY ROAD

Commencing 86 feet (26.21m) south-west of the junction with Susans Road for a distance of 32 feet (9.75m) in a westerly direction 2
