A new way of delivering housing services is being launched in March across the borough.

Homes First is the new housing services team that will deliver a more efficient way of working for **Eastbourne Homes, Eastbourne Borough Council and Lewes District Council.** 

> The team will offer a full range of housing services including housing advice, homelessness services, tenancy management, repairs and maintenance, and private sector housing.

This new initiative is part of a wider sharing of services between the two councils and Eastbourne Homes, designed to maintain and improve frontline services.

People living in Council owned stock in the Borough will remain residents of Eastbourne Homes Limited, who deliver housing management services on behalf of Eastbourne Borough Council.

The Chair of Eastbourne Homes Board, Roger Eastwood said: "I am delighted that we are launching Homes First, which will enable us to run stronger and more efficient services whilst continuing to put our residents first."

## HOMES FIRST

**Homes First** has just completed the procurement of a new service contract, which shall provide cleaning services for our blocks of flats and sheltered schemes in Eastbourne and Lewes.

The contract is being awarded to a company called Just Ask Estate **Services Ltd** who are the company currently providing cleaning services for our Eastbourne residents.

The new contract will be for an initial term of five years and Homes First

will have the option to extend the contract by up to a further five years subject to satisfactory performance reviews.

We would like to thank the tenants and leaseholders from Eastbourne and Lewes who gave up their time to join the procurement project team. They worked alongside our staff and procurement consultants PML Group to develop the specifications and service standards for the contract, and they also participated in the evaluation of the tenders we received from bidders.

We are pleased to be continuing our relationship with Just Ask Estate Services Ltd and look

forward to them providing the same quality services to our Lewes residents as they have been providing to our residents in Eastbourne for the last eight years.



## Get online to jump the queue!

Did you know the fastest way to report, apply or pay for something with the council is now via its website?

The new shared website: **lewes-eastbourne.gov.uk** has been live since November 2017 and has already helped tens of thousands of people skip the queue and get their requests sent straight through to the right team. It has the added benefit of being available 24 hours a day, 365 days a year, unlike the council offices, which are closed outside normal working hours.

Of course, the council team is always happy to speak on the phone with anyone who cannot get online or who needs a little extra support.

## Work of the Investigations Team

#### We are often asked 'What is housing fraud?'

The simple answer is that Eastbourne Borough Council has an allocations policy that determines who can apply to live in social housing within Eastbourne, and which of the applicants are offered housing based on an assessment of their needs. It is fraud for anyone to try to obtain social housing by deception or by misrepresenting their circumstances. Once a tenant of Eastbourne Homes, it is fraud for the tenant to sub-let all or part of their home. Also, if the tenant no longer occupies the property as their main or principal home, the Council

may end the tenancy to ensure that the property is available once more for people in genuine need of a place to live

Working closely with colleagues in Homes First, it has been one of our priorities to deal with cases of tenancy abandonment in which properties lie empty after tenants have moved elsewhere because their family circumstances have changed or they have needed to change jobs. These situations are a common feature of modern life, but it is not acceptable for tenants who are experiencing these changes to think that they can keep

their property permanently empty while they lead a new life elsewhere.

Applying the same investigative techniques also allows the team to identify properties that are sub-let, and the Council will always take strong action against those tenants who feel it is acceptable to abuse social housing in this way.

Since January 2017, the Investigations Team has also been operating a new regime of checks on Right to Buy (RTB) applications to prevent and detect fraud, and protect the Council against money laundering. This is being done because specific pieces of legislation mean that the Council must ensure that each application is valid and that homes are not purchased through the scheme using the proceeds of crime. The checks involve the Council obtaining additional information from applicants, and the information enables the Investigations Team to confirm the identity of the applicants and that they live in the property as their main and principal home, and that the purchase funds are from a valid source. Where the checks have been verified, the RTB application can proceed as normal to the tenant successfully purchasing their home.

## Report a fraud against the Council

If you want to report a fraud to us, all the information you provide will be treated with strict confidentiality. You don't have to give us your name and contact details; however this can be useful if we require further information from you. You can report a suspicion of fraud in the following ways:

## Direct Debits are an easy, simple and convenient way to pay your rent.



#### It means that:

- You no longer have to worry about paying your rent on time.
- It costs nothing to set up and can be cancelled by you at any time.
- It costs Eastbourne Homes less to collect, and any money we save means there is more money available to help improve the service you receive.

#### We offer:

- Monthly Direct Debits, taken on the first of every month.
- Fortnightly Direct Debits, taken on the Monday of every rent paying fortnight.
- Weekly Direct Debits, taken on the Monday of every rent paying week.

## Pay your service charges by Direct Debit and get £10 credit!

Eastbourne Borough Council tenants and leaseholders who switch to Direct Debit for the first time and pay their service charges by Direct Debit continuously for three months, are eligible for a one-off credit of £10.

This applies to the first Direct Debit on your account only. If your Direct Debit bounces or is cancelled within three months, the credit will be removed.

## Opening of Pear Tree Court,

**Sumach Close** 

Thirteen families moved into their brand-new flats in time for Christmas after the official opening of Pear Tree Court in Eastbourne on 4th December.

The 13 one- and two-bedroomed flats in Sumach Close, Hampden Park, were opened by Eastbourne Mayor Councillor Pat Hearn after completion of the £2 million development, which is managed by Eastbourne Homes.

Members of the Eastbourne Homes board were joined at the opening by children from Oakwood Primary Academy, who buried a time capsule in the footings of the site at the start of the year and contributed to the naming of the development.

Councillor David Tutt thanked the children for their contribution to the project and developers Trinity Homes.



### £1.2million boost for new homes in Eastbourne

Eastbourne Borough Council has been successful in securing £1.2million from the government's housing infrastructure fund.

The grant will help the council bring forward the development of 102 new homes at the recently acquired site in Bedfordwell Road.

This well-known location runs parallel to the railway line at Whitley Road Bridge and includes the disused pump house which will also be renovated.

Councillor David Tutt, Leader of Eastbourne Borough Council, said: "I am delighted that council officers have secured this funding, it is excellent news and will help deliver an important local housing project."

The first phase of works is due to start in late February and will focus on site preparation including land remediation works.



## Holocaust Memorial Day commemorated in

THE POWER HOLOCAUST MEMORIAL DAY 2018
OF WORDS

**Eastbourne** 

Eastbourne people came together to mark Holocaust Memorial Day with two special events that remembered those who suffered under Nazi persecution and in subsequent genocides.

Organised and sponsored by Eastbourne Borough Council, the first event was a film screening of "Nicky's Family" at the Town Hall. The documentary retold the true story of Sir Nicholas Winton's extraordinary efforts to rescue 669 children just before the outbreak of World War II.

The second main event at the Tennis Centre, with the theme "The Power of Words", was hosted by Carolyn Heaps, Faiths' Champion for the Council, and opened by The Mayor of Eastbourne Councillor Pat Hearn.

The main speaker was Gaby Weiner, Visiting Professor at Sussex University, who spoke about her family arriving as refugees in Britain.

Two children, Jess and Rosie Copeland, narrated excerpts from Anne Frank's diary and there was a performance from The International Voice Orchestra.



Eastbourne MP Stephen Lloyd closed the event that was also attended by Chair of Lewes District Council Councillor Stephen Gauntlett and Chair of East Sussex County Council Councillor Michael Ensor

Leader of Eastbourne Borough Council Councillor David Tutt said: "Tragically, since the Holocaust, genocides have continued to happen in Cambodia, Rwanda, Bosnia and Darfur. Events like Holocaust Memorial Day remind us of how important it is to remember those who have suffered and to learn lessons from the past so that we can create a better future.

"We were delighted with how well attended both events were and the feedback we have received following the events has been extremely positive."

## **Equality and Fairness**

Eastbourne Cabinet has now approved a new Equality and Fairness Policy and set of Equality Objectives for 2018 to 2021, following wide consultation with local residents and organisations.

The majority of those who responded to the consultation were in favour of the new policy and objectives.

Cabinet also considered a review of the work carried out in 2017 and agreed an Action Plan for 2018. A Gender Pay Gap review is being carried out and will be published shortly. The Plan also includes an action to commemorate the centenary of the Representation of the People's Act 1918 which extended the right to vote to all men over the age of 21 and to some women over the age of 30, and the anniversary of the 1928 which introduced full suffrage to all men and women over the age of 21.


We will be organising regular planned meetings, going forward.

## Loan **Sharks**

Loan sharks are illegal lenders who often target vulnerable people.

They charge high interest rates, are not registered businesses and give little or no paperwork to confirm their arrangements. They are also known to use illegal action to collect money they have lent, such as threats of violence or taking away your credit cards or valuables.

Some loan sharks threaten their victims by saying that they will be prosecuted and sent to prison if they don't pay. This can't happen, as unauthorised lenders have no legal right to recover debt. If a lender isn't registered with the Finance Conduct Authority (FCA) they are breaking the law if they lend you money.
