

Right of freeholder etc to be notified of licensing matters

A person (which will include a business or company) with a property interest in any premises situated in the licensing authority's area may give notice of their interest to the authority using the prescribed form below and on payment of the fee £21 (cheques should be made payable to 'Lewes District Council').

Registration is discretionary and not therefore a legal requirement.

Those who may take advantage of this arrangement may include:

- the freeholder;
- the leaseholder;
- a legal mortgagee in respect of the premises;
- a person in occupation of the premises; or
- any other person as prescribed by the Secretary of State.

Notice effect

The notice will have effect for 12 months, but a new notice can be given every year.

Whilst the notice has effect, if any change has been made to the Licence, the licensing authority must notify the person who registered an interest of the matter to which the change relates.
