Background

Homes First, the housing service for Lewes District Council and Eastbourne Borough Council (in partnership with Eastbourne Homes Limited), believe that tenants, leaseholders and people living with them should not live in fear of violence or abuse.

We take all forms of domestic abuse seriously and are committed to providing a sensitive and confidential response to anyone who approaches for assistance in cases of domestic abuse.

Our draft Domestic Abuse Policy outlines the approach we take to assist and support people experiencing or threatened, with violence or abuse. The policy has been developed in consultation with our tenants.

The scope of the policy includes all tenants, leaseholders and people living with our tenants and leaseholders. It also applies to customers accessing housing via the housing waiting list and customers accessing support from our Housing Options and Wellbeing Team. Non-housing customers will also benefit from an increased awareness of domestic abuse issues and support amongst staff across the councils as a result of the policy and DAHA accreditation. For example, general staff will be better able to identify where abuse could be occurring and escalate or signpost to appropriate support.

The Policy is part of the councils' ongoing work towards the Domestic Abuse Housing Alliance (DAHA) accreditation. You can find more information about DAHA and its key aims at **www.dahalliance.org.uk**

How we consulted

From Monday 6th June to Wednesday 5th July 2023, we invited feedback from tenants, leaseholders, residents, and statutory and voluntary partners for their views on our draft Homes First Domestic Abuse Policy.

We undertook the following activities:

- Published the draft strategy on our website.
- Made an online survey available and offered this in other formats and languages.
- Promoted the consultation via a press release to the local media.
- Published a news story on the council website.
- Sent an email to our mailing lists for housing, news and consultations (about **36,000** recipients in total).
- Promoted the consultation repeatedly on all council corporate and housing social media profiles.
- Ran a live Q&A with the Leader of Lewes District Council and Lead Member for Housing in Lewes alongside the specialist leading the consultation.
- Emailed all Lewes District and Eastbourne Borough councilors.
- We sent a briefing to our call centre staff.
- Sent a reminder email one week before the consultation closing date.

We wrote to the following organisations inviting them to comment on the policy:

- East Sussex County Council Including their Voices of Lived Experience Board (VOLEB) which is a pan-Sussex group made up of former victims/survivors of domestic abuse who are active and engaged with supporting domestic abuse related work across Sussex.
- Change Grow Live: Domestic Abuse Service East Sussex The local provider of domestic abuse related support services.
- Clarion Provider of emergency Refuge accommodation in East Sussex.
- Switchboard A domestic abuse service for LGBTQ people based in Brighton.

We also approached our involved tenant groups in the consultation process with the assistance of our Tenant Involvement Team. This included:

- Tenants of Lewes District (TOLD)
- Residents Voice (Eastbourne)
- Tenants Communication Panel
- Virtual 300

We also had a face-to-face feedback session with tenants at the Tenants Resource Centre in Lewes which was facilitated by a Senior Caseworker in the Tenant Involvement Team.

A summary of the responses we received through the consultation is available below.

Updates to the policy following consultation.

From the consultation there were some themes identified that have helped us to develop the policy further ahead of its next steps.

- Who/What is 'Homes First' Following feedback we have included a clear definition of what Homes First is and its role within Eastbourne Borough and Lewes District Councils. We have also tried to be clearer about how the policy can apply or affect those who may not be a Homes First tenant or leaseholder.
- A simple definition of 'Domestic Abuse' We have replaced the definition that was taken from the DA Act 2021 and replaced it with a simple clear definition. We have also highlighted the Appendix document 'Types of Domestic Abuse' in a more prominent position. This document contains more detailed descriptions of types of abuse and will be published alongside the policy as an accompanying document.
- Language/Tense Following feedback we have tried to be consistent with the language and tense used in the policy. We have favored a 'we will/you can' style over a more formal 'victims/survivors can' type of language. We have also used footnotes to further explain key terms such as MARAC (Multi Agency Risk Assessment Conferences) and 'Sanctuary Schemes'

• Different Victims – We have ensured that we have highlighted the fact that domestic abuse can and does happen to different groups of people and we have highlighted our understanding of this intersectional experience.

Next steps

Homes First officers have considered the feedback received through the consultation and have updated the policy.

The revised policy will go to the Eastbourne Homes Limited Board for further comment before being submitted to the relevant Lead Cabinet Members in each authority for approval.
